When you order Lipivir® we will collect and process your name, address and email address, and only use these for internal business administration purposes (such as to process your Lipivir® order) and for advertising purposes related to our products.

If participation in a survey relating to Lipivir® is available to you in your country of residence and you choose to participate this may be run by a third party, but the information will be provided to, and evaluated by, us anonymously. Whilst the information collected via such surveys may be sensitive in nature, such as questions relating to your health, we use software to ensure that it is not possible to determine the identity of the person who provided the information in the survey. Please note that your participation in a Lipivir® survey is completely voluntary.

We may share your personal data with any member of our company group, with analytics and search engine providers that help us to improve and optimise the website and business partners, suppliers and subcontractors that provide services to us. We may also disclose your personal data to a prospective seller or buyer in the event of a business or asset sale or purchase, if we are under a duty to comply with any legal obligation, or to protect the rights, property, or safety of Devirex AG, our customers or others.

Information on the use of Google Analytics
